

MEMORANDUM OF UNDERSTANDING



This MOU is executed at **Delhi** on this **27th** Day of **September 2022**, between **Maharaja Agrasen College** with its office at Vasundhara Enclave, Delhi-110096 (hereinafter referred to as the "**FIRST PARTY**") of the one part and **Indian Pollution Control Association** with its office at 450/1/B-1 Street No. 14-A, Shahdara, Delhi-110 032 (hereinafter referred to as the "**SECOND PARTY**") of the second part.

Whereas the First Party has approached the Second Party to undertake the project of Plastic Waste Management in its premises, located at Vasundhara Enclave, Delhi-110096 on their behalf. The agreement is made initially for Six months and may be extended further on mutual agreement after Six months on the same terms and conditions.

Now therefore it is agreed between the two parties as under:

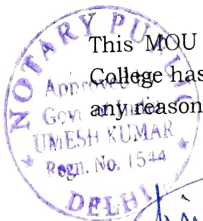
- The Second Party will do the following jobs:
 - They will collect Plastic Waste from the common point of first party located at Vasundhara Enclave, Delhi-110096 on as and when required basis.
 - They will collect the segregated plastic waste and do the further segregation as per the different categories of plastic at their cost.
 - To collect the segregated plastic waste, they will send their commercial vehicle with worker for loading the waste material.
 - They will be responsible for the recycling of collected plastic waste through authorized recyclers at their own cost.
 - They will provide recycling certificate on monthly basis to the first party.
 - All activities from collection to recycling shall be carried out in ecofriendly manner.
- The Second Party neither pay nor charge from the First Party for its services.
- Maintenance of vehicle will be the responsibility of the IPCA at their cost.
- Either party can terminate this MOU by giving one month notice in writing.
- This agreement is for a period of Six months from the date hereof.
- IPCA will always send a representative with company ID card along with authorization letter to the collection centers premises.


7. IPCA indemnify the liability for payment of all statutory dues and agrees to fulfill all the provision and statutory obligation under the applicable Acts, under intimation to Waste Management Committee.

ENVIRONMENTAL AND ETHICAL COMPLIANCE

IPCA shall also comply with all applicable legislation, rules, regulations or orders relating to environmental management and any internationally recognized standards or Green Partner policies for ethical environmental management. Green Partner may, where appropriate, request improvements in IPCA practices to ensure compliance with the said principle. Further, IPCA shall implement an environment management system (EMS) based on the principles of ISO 14001 standard or similar international standard. IPCA shall encourage the adoption of the principles therein by its subcontractors.

This MOU is signed at New Delhi on this **27th** day of **September, 2022**. Further, The College has all the rights to modify the policy/reject the MoU at any time without assigning any reason thereof.
